

PRIVACY POLICY OF MEDIA MINE Ltd.

1. DEFINITIONS

1.1. Administrator or Media Mine - Media Mine Ltd., with its seat in Warsaw, entered into the register of entrepreneurs kept by the District Court in Warsaw under the number:

0000357700, NIP: 5272628324, REGON: 142433536.

1.2. Personal data - any information about a natural person that can be determined due to one or more specific factors relating to the physical, genetic, mental, economic, cultural or social identity, including - if they allow the User identification- device IP, location data, Internet identifier and information collected through cookies and other similar technologies.

1.3. Privacy Policy - this document.

1.4. GDPR - Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals concerning the processing of personal data and on the free movement of such data, and repealing Directive 95/46 / EC (general regulation on the protection of data).

1.5. Website or LIVEFILHARMONIA.SZCZECIN.PL - website run by Media Mine at www.livefilharmonia.szczecin.pl

1.6. User - any natural person visiting the website www.livefilharmonia.szczecin.pl.

2. PROCESSING OF PERSONAL DATA AND THEIR SCOPE

2.1. Users' personal data are processed in the manner specified by generally applicable law, in particular the Act of May 10, 2018, on the protection of personal data, the Act of July 18, 2002, on the provision of electronic services and the Regulation of the European Parliament and of the Council (EU) 2016/679 of April 27, 2016, on the protection of natural persons concerning the processing of personal data and the free movement of such data, and repealing Directive 95/46 / EC (General Data Protection Regulation) - otherwise known as "GDPR" (applicable from 25/05/2018 with new national regulations).

2.2. When the User uses the Website, the Administrator collects their data to the extent necessary to provide the services offered, and specific information about the User's activity on the Website.

2.3. The Administrator collects the following Users' data: a) location data, device IP, b) information collected via cookies, c) email address, d) password, e) user name.

2.4. The User may set up an account at livefilharmonia.szczecin.pl by completing the registration form (in which the data required to set up an account are appropriately marked, and the remaining data - if provided in the form - are optional and not necessary to create an account) why the User may take advantage of additional functionalities or services of the Website. In this case, personal data provided in the registration form and information on the website's use are processed. Providing personal data is not a statutory requirement, i.e. the User has no legal obligation to provide data to create an account at livefilharmonia.szczecin.pl. At the same time, providing data marked as required is a condition for creating an account on the Website. Failure to provide data marked as required makes it impossible to set up an account at livefilharmonia.szczecin.pl and use the functionalities that, according to the Website regulations, can be used only after creating an account.

3. COOKIES AND OTHER TECHNOLOGIES

3.1. The Administrator uses the so-called cookies or other identical technologies to provide the User with access to the Website, improve its operation and display content tailored to the User's needs.

3.2. The administrator distinguishes the following cookies that are necessary to use the Website:

- a) cookies with data entered by the User (session ID);
- b) authentication cookies used for services that require user input cookies for the duration of the session; authentication for the duration of the session (authentication cookies);
- c) cookies used to ensure security, e.g. used to detect fraud in the field of authentication (user-centric security cookies);
- d) session cookies of multimedia players (e.g. flash player cookies), for the duration of the session (multimedia player session cookies).

3.3. The User may change the settings of cookies or similar technologies at any time by changing the privacy settings in the browser or application or by changing the settings of their account on the Website, with the reservation that this change may result in the lack of access to some of the Website's functions.

3.4. Detailed information on changing privacy and cookie settings is available on individual browser providers' websites.

4. LEGAL BASIS OF THE PROCESSED DATA AND THEIR PURPOSE

4.1. The Administrator processes Users' personal data to:

- a) provide access to the Website - under art. 6 sec. 1 letter B of the GDPR;
- b) perform obligations resulting from legal provisions - under art. 6 sec. 1 letter C of the GDPR;
- c) implement the following legitimate interests of the Administrator or a third party - under art. 6 sec. 1 letter F of the GDPR:
 - i. own marketing, including profiling, in particular presenting behavioural advertising, displaying marketing content to the User on the Website or sending notifications to selected Users about interesting offers or content by electronic means of communication, in particular by email, provided that the User has given appropriate consent, and also conducting other types of activities related to marketing, e.g. satisfaction surveys.
 - ii. detection and elimination of possible abuses;
 - iii. keeping statistical data for the Administrator.

5. PERIOD OF STORAGE AND PROCESSING OF PERSONAL DATA

5.1. Personal data will be processed until the account on the Website is deleted, and then for the period of:

- a) necessary for the performance of obligations under generally applicable laws,
- b) for the period of limitation of claims and until the end of civil, enforcement, administrative and criminal proceedings requiring data processing, and in the case of consent, until the purpose of consent is achieved or its revocation, whichever occurs first.

5.2. The user can delete cookies from their device themselves. The process of deleting the cache and cookies should be done in a given browser's options, and it may vary depending on the provider and browser version.

6. USER RIGHTS

6.1. The User has the following rights in connection with the processing and storage of their personal data:

- a) to rectify the data - if the collected data is incorrect or if the data changes, the User has the right to provide correct and up-to-date data,
- b) access to data - the User has the right to access the stored data,
- c) to delete data, the so-called "Right to be forgotten" - the User may delete the account on the Website;
- d) to limit data processing - if the User believes that not all their data should be processed,
- e) to object to the processing of data based on the legitimate interest of the Administrator or a third party,
- f) to withdraw consent at any time - the User has the right to cancel the permission granted regarding the processing of data at any time and without giving any reason; the withdrawal of consent is not retroactive;
- g) to consider the application for implementing the above rights, the Administrator is entitled to verify the User's identity, which allows preventing disclosure of information about the User to unauthorized persons.
- h) The User may submit a complaint regarding the processing of personal data to the supervisory body dealing with personal data protection. In the Republic of Poland, the supervisory body is the President of the Personal Data Protection Office.

7. OTHER ENTITIES AUTHORIZED TO STORE DATA

7.1. Users' personal data are also stored by entities cooperating with livefilharmonia.szczecin.pl, i.e. a server and technology provider, and to send marketing and technical information, only to the extent necessary for their activities.

7.2. Above entities ensure an adequate level of personal data protection.

8. SECURITY OF STORED DATA

8.1. The administrator conducts constant checks to ensure that personal data is processed safely by them - ensuring, above all, that only authorized persons have access to the data and only to the extent that it is necessary due to the tasks they perform. The administrator secures data before disclosure to unauthorized persons. The administrator makes sure that operations on personal data are recorded and performed only by authorized employees and associates.
